In respect of above subject and reference, we inform that your application for starting one successive/additional class in your school with condition not to take grant permanently, is received. On verifying it, the Hon'ble Gujarat High Court has issued permanent injunction against the E.D. resolution No. UMASH/1295/EMR/63.GA-1 dated 28/8/98 in respect of Sp. C.A. 10660/98 dt.21/12/98. As per the provisions vide Sr. No. 1 to 12 of E.D.'s resolution No. UMASH/1295/EMR/63.GA-1 dated 31/1/97 and taking into consideration the provisions of E.D.'s resolution No. UMASH/1295/EMR/63.GA-1 dated 1/10/97, approval is granted with following conditions for starting of successive one class of Standard 9th with condition not to take grant permanently.

1. This approval is given with condition that grant will not be taken permanently, the institution will not have right to make claim for the grant.

Admission to the students will be given as per the strength decided by the Government.

To teach the syllabus in the school as decided by the Government.

Fees to be taken as decided by the Government from time to time.

If the class or school, without grant, is closed, the teachers of the School will not get benefit of protection given to surplus teachers by the Government. And responsibility of such surplus teachers will be of the institution.

Salary, pension and all financial responsibilities of the employees appointed on account of this successive/additional class will be of the institution.

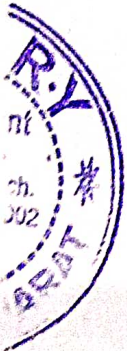

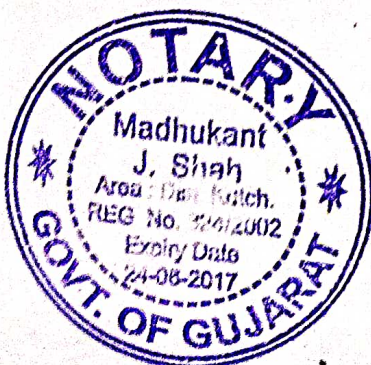

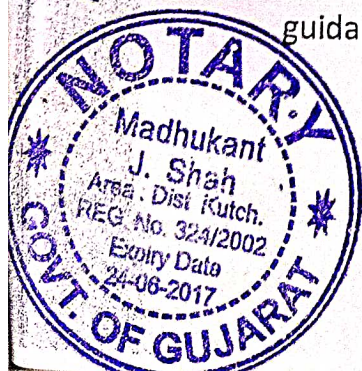

- 3 Appointment to be made of qualified Principal as per the rules on account of starting of 10th class and before starting the 10th class, School should get approval of its staff profile by the District Education Officer's office.
- 4 To arrange for laboratory, Science articles and other educational articles suitable for 10th Standard syllabus.
- 5 To purchase suitable and useful books for supplementary reading for the prescribed syllabus for teachers and students and make the school library rich.
- 6 To ensure that no unhealthy competition is made with local or nearby schools for increasing the number of students.
- 7 Amount as per the rules is to be kept in the joint account. And salary of teachers will be paid from this.
- 8 Technical schools must have facility of Land, Hostel, workshop, etc. befitting to the industry.
- 9 In this class, students of this school are required to be admitted first. No partiality can be made in the admission of students.
- 10 If the school is registered without the grant, then conditions laid down in the Government's letter No. BAMASA/1093/1322/CHH dated 17/7/93 and Education Department letter No. BAMASA/1293/1322/CHH dated 21/7/93 is to be followed.
- 11 Hon'ble Gujarat High Court has issued injunction in Sp. C.A. 1066/98 against the E.D.'s resolution dated 28/8/98. Approval of this 10th standard class is subject to final decision of this case.
- 12 This approval is given with the condition that all approvals were taken for the construction of the building and sports ground. The D.E.O. will verify this.

If the certificates/evidences are obtained from the Universities/institutions, outside of Gujarat State, verification of such certificates/evidences will be done by the School board by visiting the respective Universities/institutions in person and School Board will be responsible for this.

Institution/Administrative board will make all arrangements for the safety including fire safety.

NOTE: Registration fee of Rs.200/ for the academic year 2005 is to be sent, along with application forms, to the Examination Department, Vadodara. And thereafter time to time fees are to be paid in the Vadodara Office.

It is informed that after 15 days of starting the class, to submit the report to the Board and your District Education Officer, whether above conditions are fulfilled.
